INTERNATIONAL STUDENT FINANCIAL GUARANTEE FORM

The United States Department of Homeland Security (DHS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. Therefore, Hartford International University requires a guarantee of financial resources from each applicant who expects to obtain or maintain F-1 student status.

WHAT YOU NEED TO KNOW:

- Applicants are required to submit financial documentation that equals or exceeds nine months of expenses for the program of study they are interested in pursuing.
- A Form I-20 will not be issued until this financial guarantee form is completed.
- Financial documentation is valid for six months from the date of signature on this form or date of bank statement submitted.
- Although scholarships are available for qualified international students, they only cover a small portion of tuition and in most cases may not be relied upon to cover all educational costs. For more information regarding scholarship opportunities available at HIU, please visit <u>here</u>.
