This course surveys four themes with reference to major religiously defined identity groups among Muslims:

- 1) Remembering & Revering the Prophet
- 2) Community: Ritual & Law
- 3) Renunciation, Asceticism, and Mysticism
- 4) Theology and Philosophical Thought

Three successive weeks will be devoted to reding and discussing material on each theme.

Syllabus: First Draft 12th September 2025 (Subject to multiple revision):

Pedagogy: This course is based on reading and in-depth discussion: Primary and secondary sources will be read and discussed.

Students are encouraged to engage various online resources, including generative AI engines.

Required Work & Evaluation:

On the average, 70-140 pages of readings are assigned per week.

Students should prepare for class by reading all assigned texts for each session.

Online participation & Attendance:

Attendance, keeping up with assigned readings and active participations are important in this class.

Note: More than two unexcused absences result in a failing grade.

Offline discussion

Students are expected to respond to assigned readings before each class session by posting questions and comments on weekly discussion threads on CANVAS. Reponses posted closer than three hours to class time will be disregarded.

Writing assignments:

- 1) Four responses (each about 1200-1500 words in length), one for each theme:
- 2) A final research paper, 3500-4000 words: specific topic to be decided in conference with the instructor. Topics will be assigned in class. (Progress to be assessed beginning the fifth week of the semester).

Note: Late submissions are *not* accepted.

Grading: The following formula will be used to calculate the final grade for each student: Regular and timely online attendance & participation (10%) + Responses (4 x 15%) + Final Paper (40%) (adds up to 110% in favor of the students)
